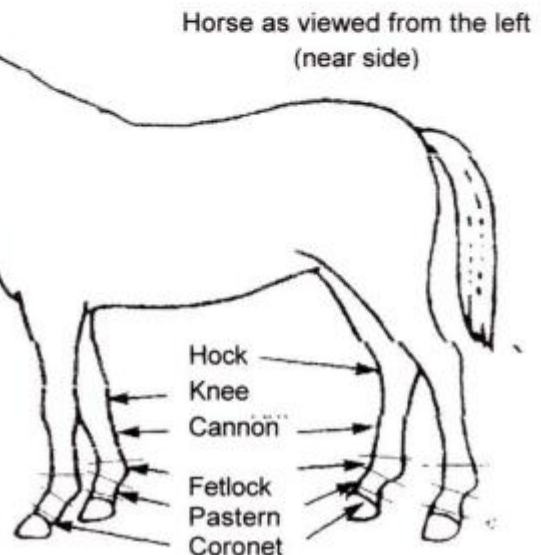
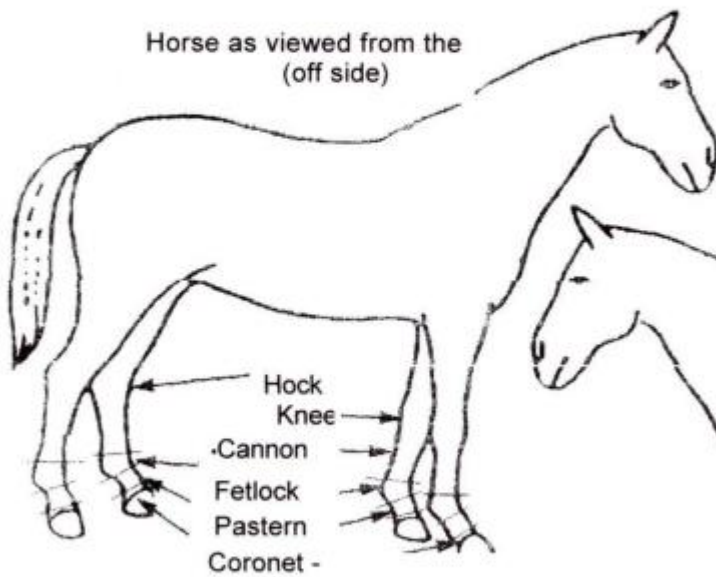
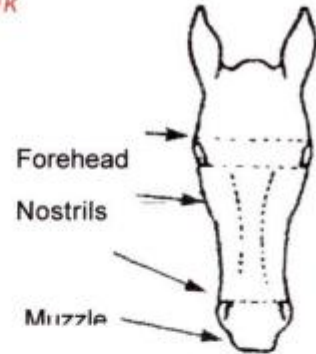
Applicants are requested to follow these instructions when filling in the forms and completing the diagrams

1. White markings must be shown in black on diagrams exactly as they appear on horse
2. White markings, if present, must be shown on both near and off side diagrams
3. The position of scars, accidental or otherwise, to be marked on diagrams with an X
4. Brands must be shown on the diagrams exactly as on the horse
5. Whorls to be marked with a small circle.

*Draw all white markings on the diagrams in ink*

**WHITE MARKINGS ON HEAD**

- STAR - Any markings on forehead
- BLAZE - Wide marking covering most of the face
- STRIPE - Narrow marking running down nose
- SNIP - Marking in vicinity of nostrils
